BE IT ORDAINED BY the Town Council of Winfall, North Carolina, meeting this 18th day of June 2020 that the following be the budget for FY 2020-2021:

The Finance Officer is hereby authorized to execute the necessary agreements within funds included in the Budget Ordinance for the following purposes: (1) Leases or normal and routine business equipment where the annual rental of each is not more than \$20,000; (2) Professional or maintenance service agreements where the annual compensation of each is not more than \$20,000;

- (3) Purchase of apparatus, supplies, materials or equipment formal bids are not required by law;
- (4) Agreements for acceptance of State, Federal, public, and non-profit organization grant funds and funds from other governmental units for services to be rendered; Liability, health, life, disability, casualty, property or other insurance or retention and faithful performance bonds. Other appropriate Town officials are also authorized to execute or approve such insurance and bond undertakings as provided by law.

There is hereby levied a tax at the rate of fifty-four (\$0.54) per one hundred dollars (\$100) valuation of property as listed for taxes as of January 1, 2020, for the purpose of raising the revenue listed as "Property Tax" and "Vehicle Tax" in the General Fund in the revenue section of this ordinance.

The estimated rate of collection is based on the current fiscal year collection rate of 95.0%.
