# TOWN OF WINFALL TOWN COUNCIL MEETING January 14, 2019 7:00 PM WINFALL TOWN HALL, WINFALL, NC 27985

The regular monthly meeting of the Winfall Town Council was called to order by Mayor Fred Yates at 7:00 p.m... Invocation was given by Councilman Steav Congdon and the Pledge of Allegiance was led by Mayor Yates.

# Mayor Yates:

A. Other Business: Debbie Whedbee discussed a problem with the pole light near her home. Mayor Yates told her to find the number on the pole and to contact the office. Mayor Yates read aloud a Religious Freedom Day 2019 Proclamation and entertained a motion to pass the proclamation by the Winfall Town Council. A motion was made by Councilman Steav Congdon to pass the proclamation proclaiming January 16th as Religious Freedom Day and was seconded by Councilman Preston White and so carried. Mayor Yates shared with the council and public the dates the Winfall Town Office is closed for holidays for 2019. Chief Thomas Roach told Council that they wanted to apply for a 50/50 grant. Mayor Yates entertained a motion. A motion was made by Councilman Steav Congdon for the Town of Winfall Volunteer Fire Department to apply for a 50/50 grant and was seconded by Councilwoman Arnetta Ormond and so carried. Councilman Preston White rescued himself from voting being a member of the Volunteer Fire Department. Mayor Yates shared with Town Council the information listed in the newspaper regarding being double tax by the 911 fees. He told them he had a meeting January 14, 2019 with the town manager, county manager, and the mayor of Hertford. They all went into a contract with the county for dispatch and 911 some years ago. He said are paying someone else to do what we should be doing ourselves. When the fire department is called that's 911. They are doing a good job and they are not getting paid. Without their services we couldn't make it. We are not being doubled tax according to the news article dated January 9, 2019. The Volunteer Fire Department is selling tickets for a pancake supper February 28, 2018. The cost is \$8.00.
