# TOWN OF WINFALL TOWN COUNCIL MEETING May 14, 2018 7:00 PM WINFALL TOWN HALL, WINFALL, NC 27985

The regular monthly meeting of the Winfall Town Council was called to order by Mayor Fred Yates at 7:00 p.m... Invocation was given by Councilman Steav Congdon and the Pledge of Allegiance was led by Mayor Fred Yates.

Those in attendance were Mayor Pro-Tem Debbie Whedbee, Councilman Preston White. Councilman Steav Congdon, Councilman Kenneth Rominger, and Attorney William Crowe.

Mayor Yates asked Council if there was a **conflict of interest**. Mayor Yates turned the meeting over to Mayor Pro-Tem Debbie Whedbee because his wife Arlene Yates would be speaking which may pose a conflict of interest.

## **Financial Report:**

Mrs. Yates asked Council could the Town of Winfall Community Center be used for that purpose, It was put into motion by Councilman Steav Congdon for her to use the Town of Winfall Center and was seconded by Councilman Preston White and so carried.

Mayor Yates presented to Council the 2018 Audit contract from Winston, Williams, Creech, Evans & Company, LLP for approval. Councilman Steav Congdon made a motion to approve the 2018 audit contract and was seconded by Councilman Preston White and so carried.

Sharon Smith from TDA was absent from the meeting. Mayor Yates said Sharon was asking the Town of Winfalll for \$2,500 towards her salary. It was put into motion by Councilman Kenneth Rominger to offer \$2,000 and was seconded by Councilman Steav Congdon and so carried.

Mayor Yates told Council that the new post office was opening on Tuesday and the hours of operation are Monday thru Friday 1-5 p.m. and Saturday 8:30-11:00 a.m.
