

Other Business:

A. Mayor Yates discussed a few ordinance regarding the Town of Winfall

1. Ordinance setting forth the duties of the Mayor of the Town and the January 11, 1995 minutes confirming the motion and second vote.
2. Ordinance providing for the removal and disposition of abandoned, nuisance and junked motor vehicles. Particularly one located on white Street.
3. Mayor Yates read a part of the ordinance prohibiting loitering in the Town of Winfall. He discussed Loitering and children playing basketball in the streets. When he see them loitering he reminds them to move on.
4. Mayor Yates asked Council if anyone was interested in attending Albemarle Hopeline Annual Legislative Breakfast Wednesday, March 6, 2019. Mayor Yates and Councilman Ken Rominger said they will attend and bring back information. He also shared with the Council, the Chamber of Commerce list of Board of Directors Officers for 2019.
5. Mayor Pro-Tem Ken Rominger shared information about the Community Leaders Group and what the group is about. He talked about the tying of bags in the garbage can and that he had questions regarding the upcoming River Bash scheduled for March 3, 2019 through March 5, 2019.
