# TOWN OF WINFALL TOWN COUNCIL MEETING October 14, 2019 7:00 PM WINFALL TOWN HALL, WINFALL, NC 27985

The regular monthly meeting of the Winfall Town Council was called to order by Mayor Fred Yates at 7:00 p.m... Invocation was given by Councilman Steav Congdon and the Pledge of Allegiance was led by Mayor Yates.
